**Subject:-Hiring of Contractual Staff for setting of Addiction Treatment Facility (ATF) under National Drugs Dependence Treatment Centre for Govt. District Hospital Reasi.**

As approved by the Ministry of Social Justice and Empowerment (MoSJE), Government of India and nationally coordinated by the National Drug Dependence Treatment Centre (NDDTC), AIIMS, New Delhi vide communication dated 26/09/2025, duly endorsed by the Worthy Chairman, District Health Society (District Development Commissioner), Reasi, and in pursuance of the directions received from the Vice Chairman, District Health Society (Chief Medical Officer), Reasi vide office letter No:CMO/Rsi/NHM/2955-58 dated:09/01/2026, applications are hereby invited from eligible candidates of District Reasi for engagement against the below-mentioned posts for the **Addiction Treatment Facility(ATF)** at Government District Hospital, Reasi. The facility is being implemented under the National Drug Dependence Treatment Centre (NDDTC), AIIMS, initially for a period of one (01) year (2025-2026), extendable on a yearly basis subject to satisfactory performance and conduct, or till the continuation of the centrally sponsored scheme, whichever is earlier.

01. The Candidate must be domicile of District Reasi (Medical Jurisdiction/local criteria) (UT of J&K).
02. Local criteria as applicable under rules shall be followed for selection.
03. Age limit has been specified from 18-45 Years.
04. Remuneration as mentioned above is all inclusive & may increase or decrease subject to approval from the competent authority.
05. The hiring is purely on contract basis upto end of this financial year i.e. 31st March 2025, renewal for a period of 01 year at a time, based on performance and continuation of the Scheme. The District Health Society has right to terminate the hiring without assigning any reason.
06. The Candidate shall have to give one (01) month notice before leaving the contractual services.

07. The Contractual appointee shall have to enter into contract with the District Health Society, Reasi.
08. The Contractual appointee shall not be entitled to any preferential claim for regular appointment under normal process of Selection & is non-transferable.
09. In case of female married candidates for the above said posts, the residential proof will be considered from in-law side or marriage certificate.
10. No TA/DA will be given to candidate for appearing in the interview or written test.
11. In case of any deficiency/forgery in genuineness found in documents of any candidate at any stage during verification of documents or known from any reliable sources, his/her candidature/selection for engagement shall be disqualified/terminated.
12. Application(s) can be rejected by the Recruitment Committee, if found not falling in the required criteria.
13. The Hiring shall be governed by other terms and condition as are not specifically mentioned herein but are made applicable in case of such appointments at any time by the contracting authority.
14. The posts may increase or decrease subject to the availability of Posts or sanctioning of Posts from Competent authority for the next Financial Year/current financial year.
15. In case, the number of applying candidates is more than 10 times of the total available seats, then 1:10 ratio as per posts shall be considered for written test and similarly 1:5 ratio for interviews shall be considered on the basis of Academic & Professional/Technical qualification, if required.
